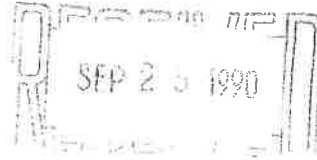

Dear Father Adamsky,

Following the recommendation of the Priests' Personnel Board and in accord with Canons 539-540 of the 1983 Code, you have been appointed temporary administrator of St. Joseph Parish, Racine, until a new pastor is appointed. This appointment is effective September 30, 1990.

As temporary administrator you come under the provisions of Canon 540 which is quoted here in full:

- §1 The parochial administrator is bound by the same obligations and has the same rights of the pastor, unless the diocesan Bishop prescribes otherwise [cf. cc. 519; 528-530; 535].
- §2 The parochial administrator may not do anything which could prejudice the rights of the pastor or could do harm to parochial property.
- §3 When he has discharged his office, the parochial administrator is to give an account to the pastor.

Note that you have the responsibility for the Pro Populo Mass on Sundays and Holy Days of Obligation [c. 534]; you are authorized to sign checks on all parish accounts to cover ordinary expenditures and to meet payroll obligations. Please note that in keeping with Canon 540, §2, no extraordinary changes are to be made. Urgent matters should be referred to the Archbishop.

Thanks, Ray, for assuming this assignment in addition to your other duties. Your willingness to do this is greatly appreciated.




Dear Ray,

As I continue to adjust to my role as Archbishop, I am undertaking a review of files of priests. I note that there have been problems in your past of which you are well aware. Father Joe Hornacek has spoken with you recently to discuss your situation with you on my behalf. If you want to meet with me personally at some point, I am certainly open to that possibility.

In the meantime, I see that a precept restricting your exercise of ministry is in place. I would like to confirm those restrictions: You are to have no unsupervised contact with minors and no public exercise of ministry; Private celebration with only another priest or priests in attendance is permitted, but no other sacramental ministry. Given the current state of matters, I would also ask that you not wear your collar in public settings, nor present yourself in public as a priest. This is for your protection as well.

I regret that my first formal correspondence with you needs to be on such a delicate and painful matter. I am sure you understand that the scope of my responsibilities in caring for the flock entrusted to me and for you requires that I do so.

Entry for the File of [REDACTED] Adamsky, Rev. Raymond

I returned a call to [REDACTED] age fifty-three. Her phone number is [REDACTED]. She reports that she met with Bishop Sklba about eleven years ago to report sexual abuse by Father Raymond Adamsky. Last year, she had a face-to-face meeting with Archbishop Dolan at Catholic Charities, at which time she was promised that Adamsky was not in active ministry anymore. Today, she saw his obituary and she was disturbed by the fact that he was referred to as Father Raymond Adamsky. I attempted to explain to her that although he was removed from active ministry, he was not laicized and still retains that title. She did not realize that there was a distinction between removal from active ministry and laicization.

I learned that [REDACTED] has been in therapy for fifteen years at her own expense. I explained to her that financial assistance from the Archdiocese for therapy is available. She requested reimbursement for past expenditures on therapy. As she does not have a file in my office, I realized that she has not received letters about the mediation system, which could help resolve this request. I outlined the mediation system for her and encouraged her to call there to register and have her questions answered. She is looking for a support group in [REDACTED] County, and I gave her the number for Sexual Assault Services in [REDACTED]. She understands that she may call me back as needed.

Yesterday Father Leo Lambert visited me to say that he was approached by Mr. [REDACTED] and his wife, [REDACTED]. These people reside [REDACTED].

[REDACTED] This arrangement was there when Father Adamsky became pastor. This last summer two of the [REDACTED] girls, ages 10 and 12, were over at the rectory a lot. Father was scene giving them piggyback rides on the playground, and they frequently watch TV in his living room with him. Recently, they came to their parents [REDACTED] is a Catholic, [REDACTED] is not. Father Leo Lambert is attempting to validate their marriage and give instructions to [REDACTED]) and told them that Father Adamsky had been kissing them on the mouth repeatedly and on one occasion even forced his kisses on them. The younger girl said that on one occasion he attempted to touch her indecently, and the older girl jumped on Father and both of them ran out the door. Father Lambert showed me a pair of women's panties decorated with suggestive writing which Adamsky had given to one of the girls for her birthday. The parents had given this to Lambert. Father Lambert did not want to bring this matter to the attention of the full Personnel Board and asked me to do something about it. I assured him I would talk to Adamsky and that we would have him evaluated by a psychologist. When Adamsky came to see me, he was somewhat nervous and I suspect he knew what this was all about. He denied categorically that he had forced kisses upon the girls or that he had attempted to touch them. He did admit to giving one of them the panties as a "joke". He said he was aware that the parents knew about this and when they did not object, he thought that everyone was taking this as a big joke. I pointed out to him the seriousness of this matter because he is being accused of child molestation by young girls and their parents. I asked him to see [REDACTED], and he agreed. I sent him there immediately and later spoke to [REDACTED]. [REDACTED] notes that Adamsky has had epileptic seizures over a very long period of time and the drug that he uses to control these seizures is one that has far-ranging side effects. [REDACTED] noted some of the symptoms that Adamsky explained to him probably are due to continuing slight seizures. [REDACTED] also detected a number of personality disorders which need attention. [REDACTED] suggests that we have him thoroughly evaluated at the Wausau Clinic. [REDACTED] and I will meet with Adamsky on Friday to discuss this further.

I met with him and [REDACTED]. [REDACTED] is concerned about some of the neurological and psychological symptoms that he sees in Adamsky and recommends that he receive a thorough evaluation in his condition. I asked Adamsky to enter the Wausau Clinic on January 31 for this type of evaluation. Adamsky said he is willing and that he would cooperate. Later I asked [REDACTED] if there is something we should be doing with regard to the parents of the children that are accusing Adamsky. [REDACTED] feels that I should talk to the parents and offer to have [REDACTED] talk to them or to the girls if this would make them feel better. [REDACTED] does not feel that the girls will be psychologically affected by this incident nor does he feel there is any reason for Adamsky to have to leave St. Kilian's as long as he undergoes evaluation and treatment if indicated.

I called Mr. [redacted] to let him know that Father Adamsky is receiving medical help and counseling following the incident that the [redacted] reported to Father Leo Lambert. [redacted] was very happy to hear this and said that everything seems to be going fine. His wife is still [redacted] and Adamsky is treating both of them as though nothing had happened. [redacted] is satisfied to leave the matter in our hands.

Yesterday, he and I drove to Wausau, and today he was given the report of his recent evaluation by the Wausau Mental Health Associates. Afterwards, the report was shared with me in his presence by Dr. [redacted], psychologist. Basically, the results were as follows:

1. In his spiritual assessment, [redacted] OFM Cap. recommended that Father Adamsky get a spiritual director with whom he can work on a regular basis in order to bring about a closer correlation between his vocation and life style. I told Adamsky I would furnish him with a list of recommended spiritual directors in the Archdiocese.
2. The physical assessment of Adamsky showed that everything here is under control. The on-going medication for epilepsy is within the normal limits as are other existing conditions. More attention to exercise is the only thing that is recommended besides, of course, on-going consultation with his doctor in Fond du Lac.
3. The psychological evaluation showed no serious abnormalities. However, it clearly shows that Adamsky does not think in psychological categories. Therefore, he does not think about or realize how he is coming across to others. The episodes that led to this evaluation were the result of Adamsky's failure to understand the normal behavior of young girls. As a young man, Adamsky did not have opportunities for dating or really getting to know women. As a result, there is a lot of immaturity in his reaction toward women. At this point in the interview I recalled how poorly Adamsky had treated a waitress the night before when we had dinner. His bitter criticism of her service, the attitude he showed turned her off and myself as well. Dr. [redacted] said that their recommendation was that while

Adamsky does not need psychotherapy for any overt condition, he would greatly benefit from seeing a psychologist perhaps once a month to try to work on seeing things from a psychological stand point.

Dr. [redacted] said that their staff feels that at this time in his life Adamsky is matched to the right assignment. They see no need of him moving because of the incident with the young girls or because of his personal condition. I told [redacted] and Adamsky that I had spoken to Mr. [redacted] the father of the girls, and that there seems to be no further desire on the parents' part to push the issue any further. They are satisfied that he is receiving counseling. At the end of the interview Adamsky was obviously relieved and said that he was grateful for this experience. He stated that he is willing to follow up with counseling once a month but not more than that. He said he would not return to counseling with [redacted] because he does not like people with beards.

On Wednesday, December 20, 1989 I went to the office of social worker, [REDACTED], in the [REDACTED] County Court House in order to meet with [REDACTED] (family name unknown) who alleges that she was sexually abused at the age of ten 25 years ago by a priest currently in active assignment in the Archdiocese. After my explaining the ways in which such issues are presently handled by the Archdiocese, she agreed to give the matter further consideration before revealing the individual's name to me.

On Tuesday, February 27, 1990 I met with [REDACTED] in the office of her therapist, Mr. [REDACTED], at the [REDACTED] County Counseling Center in the Court House in [REDACTED] to further discuss her allegations regarding sexual abuse. Ray's name surfaced in the conversation, and [REDACTED] indicated a desire to confront him in my presence within two to four months, authorizing me to make an initial contact and to make some type of intervention in this regard.

I said that in view of the lack of more specific information, I would not request an evaluation at this time, but might do so later. She was content with the process and progress and asked that we stay in touch as she prepared for the meeting.

On Friday, October 18, 1991 Bishop Sklba accompanied Father Adamsky to the office of therapist, [REDACTED], in [REDACTED] where he was confronted by the serious allegation of sexual abuse by [REDACTED] who was accompanied by Lutheran Pastor [REDACTED] (serving an ELCA congregation in Grafton) and a friend by the name of [REDACTED]. The allegation regarded sexual abuse as a ten year old child in 1963-64 which Father Adamsky denied. As a result of the statements of the Lutheran Pastor regarding practices within the Lutheran denomination, Bishop Sklba contacted Bishop Peter Rogness on Monday, October 21, 1991 to discuss procedures for handling such allegations. After consultation with Attorney Matt Flynn, Bishop Sklba indicated his intention to inform the pastor of St. Joseph Parish in Racine and Father Adamsky himself that no unsupervised contact with children was to be allowed pending further investigation and resolution of this allegation.

Bishop Sklba notified the office that on Friday, October 18, 1991 he joined Ray for a meeting at the [REDACTED] County Court House with [REDACTED] who was supported by her therapist, [REDACTED], a friend by the name of [REDACTED] and another woman by the name of [REDACTED] and a pastor associated with an ELCA congregation in the Grafton area. In response to four pages of explicit accusation regarding events which allegedly occurred in 1963-64, Ray denied all charges. I subsequently spoke with Attorney Matt Flynn to review the matter, [REDACTED]

[REDACTED] I also spoke with Bishop Peter Rogness in view of the Lutheran Pastor's assertion that such an accusation would result in a removal from the ministry in the Lutheran Church. Peter Rogness explained his practice in a telephone call on Monday, October 21, 1991 and indicated he would not automatically move in such a direction given the circumstances of this particular allegation.

Bishop Sklba also reported that he spoke with Father Richard Stoffel, Pastor of St. Joseph Parish in Racine, on Monday, November 4, 1991 in order to repeat the formal notice of the allegation to the parish. On that occasion it was decided that Father Adamsky would not be present in any religious education or day school classroom without the constant supervision of the teachers, that he would leave at least five minutes before the dismissal of all classes in order to be separated from the turmoil which often accompanies dismissal for lunch or home, that an adult would be assigned to acolyte duties at weekday masses and that the services of Father Erv Mogilka would be utilized for children's confessions.

Bishop Sklba later reported that he had spoken with Father Stoffel on Monday, November 18, 1991 and learned that a very brief explanation would be given to Father Mogilka regarding the request for help for the confessions and that Racine Attorney Mark Nielson had been retained by Father Adamsky to protect his own interests. Bishop Sklba noted that he had received a formal letter from Father Stoffel on Friday, November 15, 1991 carefully documenting all the steps taken to provide ample supervision on the part of the parish (also signed by Father Adamsky on November 11, 1991). Father Stoffel also requested that Bishop Sklba contact the parish school principal, Mr. Cooper, regarding some ambiguous expressions of concern on the part of parents approximately a year and a half previously. Father Stoffel took the occasion of a telephone conversation to ask if the parish could be reduced to a single priest assignment in the changes scheduled for June, 1992.

We need to look for an assignment and residence for Ray.

On April 25, 1995 Dr. Elizabeth Piasecki, echoing the request of Carrol Straub, suggested that I meet with Ray subsequent to the signing of the settlement by a representative of St. Philip Neri Parish in order to obtain his signature and to request a contribution of approximately \$10,000.00 toward the settlement.

Dishes are not washed adequately. Retired priests meet with Bill Kreitzer today.

Dear Father Adamsky,

As you are aware I must frequently review the situation of priests who have had allegations of misconduct placed against them. You know of my comments at the Spring Assembly for Priests where I indicated that even retired priests may have to have some restrictions placed on the ministry they can offer. My concern is both to ensure that the integrity of the priesthood is upheld and to protect the diocese from any allegations of improper monitoring which might place persons at risk.

I have pondered how best to proceed with decisions regarding your status and exercise of ministry. I must bear in mind both my responsibility toward the good of the whole community and respect for your individual rights.

Given the serious nature of the obligations of celibacy, as well as the seriousness of violations alleged to have occurred by you, I find that some necessary and prudent precautions must be taken. This decision is ultimately a pastoral measure to protect the rights and reputations of all involved.

Therefore, I am enclosing a document which specifically details any ministerial restrictions which are to be observed by you.

I know that I can count on your cooperation and obedience in this matter.


PRECEPT

In response to the pastoral needs of this Christian community, in virtue of my authority as diocesan bishop (c. 381, §1), and in accord with the provisions of canon 49, I formally place upon Reverend Raymond Adamsky the following obligations:


- 1) To refrain from all contact with minors;
- 2) To cease until further notice all public ministry including the celebration of Eucharist in other than a private setting with only another priest or priests in attendance; the celebration of any other sacraments will require my explicit permission in each case;
- 3) To avoid all places and situations that, from past experience, have been occasions of serious temptation in the area of sexual morality;
- 4) Until further notice the faculty to hear confession is revoked.

The reasons motivating this decree are the allegations of sexual activities in violation of the obligation of clerical celibacy (c. 277, §1). These restrictions are seen as necessary and prudent precautions and will remain in effect until notice of their revocation.

Dear Father Adamsky:

Following the recommendation of the Priests' Personnel Board and in accord with Canons 539-540 of the 1983 Code, you are hereby appointed temporary administrator of St. Stanislaus Parish, Milwaukee, Wisconsin, until a new pastor is appointed. This appointment is effective immediately.

As temporary administrator you come under the provisions of Canon 540 which is quoted here in full:

- §1 The parochial administrator is bound by the same obligations and has the same rights of the pastor, unless the diocesan Bishop prescribes otherwise.
- §2 The parochial administrator may not do anything which could prejudice the rights of the pastor or could do harm to parochial property.
- §3 When he has discharged his office, the parochial administrator is to give an account to the pastor.

Note that you have the responsibility for the Pro Populo Mass on Sundays and Holy Days of Obligation; you are authorized to sign checks on all parish accounts to cover ordinary expenditures and to meet payroll obligations. Please note that in keeping with Canon 540, §2, no extraordinary changes are to be made. Urgent matters should be referred to the Archbishop.

By way of a suggestion, in your appointment as temporary administrator you might read the booklet, "Parish Trustees and Administrative Services Committee Handbook", published by the Chancery, Finance, and Parish Council offices. It is a very helpful tool for administrative matters.

Thanks, Ray, for assuming this assignment. Your willingness to do this is greatly appreciated.

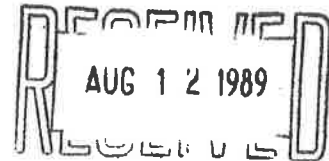

Dear Bishop Sklba;

A few weeks ago I contacted Mary Kay Balchunas in response to hearing of Project Benjamin. I was not then, and I am not now looking for referral. I am seeking answers to many questions which she was not prepared to answer, therefore she suggested I contact you.

I am an adult survivor of child sexual abuse. When I was ten years old I was sexually abused by a priest at our parish. I attended a Catholic grade school and was in constant contact with this priest. The abuse occurred daily over a period of weeks. To my child's eye this man could do no wrong. He used his powerful position to satisfy his sexual needs. It took me many years to realize that what he did was indeed wrong.

The abuse ended when the nun who was the principle of the school called me into her office and severely reprimanded me for spending time with Father. She told me to stay away from him. This firmly cemented in me the feeling that I was a bad girl - I had done something wrong - it was my fault.


The priest disappeared shortly after I was reprimanded. He was sent to another parish to continue his life and I was sentenced to a life in purgatory. He and the church's reputation were protected by the very church that I believed would always protect me and keep me safe. I never said anything to anyone - until recently. My parents never knew. I lived alone with my shame and guilt.

[REDACTED] I was a bad girl and not worthy of the church. Besides, the church had already turned its back on me. There was no one I could go to with my secret. I had no outlet. I was alone. I turned all the pain inward, and to relieve that pain [REDACTED]

I need to know what, if anything, was done to rehabilitate the priest. I need to know why the church abandoned me. I need to know if the church can sincerely commit to helping me now. I also need to speak with the priest who abused me and the nun who reprimanded me. I don't need help finding them. I have already done that. I do need to know if you will help me convince them to meet with me.

I cannot at this time feel safe enough to reveal details, my full name or the names of the priest and the nun. I sincerely hope this will not keep you from taking me seriously and responding. Before I can discuss the details with you, I'll need to know where you and the church stand on the issue of sexual abuse perpetrated by a member of the clergy. It is also important for me to know that children will be protected from abuse from the clergy in the future. When I heard about Project Benjamin I was filled with hope, but I need to know that the gesture is sincere. Please don't let the church turn its back on me again. Will you - can you - help me? I will anxiously await your reply.

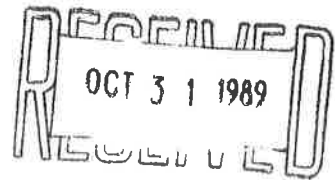

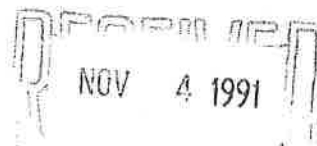

As a result of the serious allegation recently brought to my attention, and after seeking further counsel in the matter, I have no choice except to request that you henceforth avoid all unsupervised contact with minors, pending further investigation. To that purpose I have contacted Father Richard Stoffel, Pastor of Saint Joseph Parish, with the request that he take all the appropriate steps needed to protect all parties concerned, yourself included, by implementing this directive in the context of both the parish school and the religious education program. I have also requested that the parish seek legal counsel, and I would again recommend that you do the same because the issues are serious and their implications far reaching.

I also recommend that you consider seeking both spiritual direction and possible conversation with a counselor to sort out the many issues which the allegation raises, even though you deny the entire matter completely.

Be assured of our prayerful support for all parties concerned during this time of assessment. Attorney Matthew Flynn of Quarles & Brady represents the Archdiocese. He can be contacted at his office (277-5347) if further information is needed.

Dear Father Adamsky,

As a result of the letter from Bishop Sklba dated 10/30/91 which alerted me to the serious allegations brought to his attention, I must take the following steps to comply with his request that you immediately avoid all unsupervised contact with minors, pending further investigation. I discussed these possible measures with you on 10/30/91 and 11/04/91 respectively. They were developed in confidential meeting and consultation with our DRE, Mrs. Susan Gehrig, and our school Principal, Mr. Charles T. Cooper, and form our concensus as to what steps are necessary to provide protection for all parties concerned, including yourself.

- 1.) When teaching in our Saturday CCD programs or in our day school religion classes, the teacher/catechist has been directed to remain in the room as and while you are teaching/present with the children. This has been communicated to them as a matter of policy for BOTH priests when they are teaching and explained as an advantage for maintaining discipline as well as curriculum continuity so as not to raise their suspicions of anything out of the ordinary and to protect your reputation which, at this time, is merely subject to allegations unsubstantiated, unproven and denied.
- 2.) When your time of teaching a weekday religion period in the day school has been completed and/or a Saturday set of religion classes in CCD is done, I must direct you to leave the building promptly without giving the appearance of inappropriate lingering. When a religion class/period comes to an end immediately prior to school or CCD dismissal time, I must request that you end that class/period five minutes before scheduled dismissal and leave the building before dismissal begins.
- 3.) When you are celebrant of daily Masses at 6:45AM, I must direct that you have the services of an adult lector so that there is no unsupervised contact with minors in their capacities as Mass servers. I have contacted the gentleman who will help with this. He is unaware of the reason for my request and only sees it as another chance to be helpful as he currently performs that role for me.
- 4.) I must sadly ask that you cease entirely from teaching CCD on Wednesday nights for our 8th grade students. As the program cannot guarantee supervised contact for you and our minors, I cannot allow your presence to that group. The catechist has been informed only of a long-term, indefinite schedule conflict and is satisfied with that information. If you are to participate in other junior high or high school classes/events, you must be sure of supervised contact situations or decline to participate.
- 5.) Due to the unsupervised nature of the sacrament of reconciliation, I must direct you not to hear scheduled children's confessions. As the visibility & unusual nature of arrangements for hearing confessions that would be necessary to assure supervised contact with minors would themselves attract undue

5.) - continued - attention and notice, I have decided that it is in the best interests of all concerned (the parish, the children, and yourself) that a priest help-out be called in to assist me when such confessions are to be heard.

I must add my voice to that of Bishop Sklba in advising you to retain the services of legal counsel and, upon confidential advice of a parishioner lawyer, recommend the services of Mr. Mark Nielsen of Racine, Mr. Thomas Hartley of Kenosha and Mr. Phillip Godin of Kenosha. All three have familiarity with the law and cases involving such allegations. You must choose and make the contact.

I must also reiterate Bishop Sklba's advice that you seek spiritual counsel as well as professional counsel to sort out the multiple issues which such allegations raise, even though you deny the entire matter completely.

Please do not misconstrue these steps as in any way assumptions on my part of anything about these allegations or about yourself personally. Allegations are only that and no more unless further investigation proves otherwise. I must at this time accept your denial of such matters as sufficient and respect the position you take as a professional. Please be confident of my prayerful support as pastor and my assistance if or when that may be necessary. You have only to ask.

I must ask that you take the preceeding with utmost seriousness and deal with these matters in due speed because, if the present allegations are made public, there is the possibility that second & third-hand allegations made here several years of a similar nature to our principal involving some junior high students may surface. The nature of this information concerning similar allegations will be shared with Bishop Sklba by Mr. Cooper at their earliest convenience and at my specific request. This is only done for the protection of all parties.

Finally, I must ask that you and I sign this letter to give assurance that we both understand and accept the contents of this communication. Copies will be sent only to the parties noted below due to their involvement in the matters pertaining to these allegations.

Bishop Sklba notified the office that on Tuesday, November 26, 1991 he met with [REDACTED] and [REDACTED] of the Office of ELCA Bishop Peter Rogness to discuss [REDACTED] needs. He reviewed all the steps which he had taken subsequent to the meeting on October 18, 1991 in [REDACTED] and stated that he would seek the additional information from the Principal of St. Joseph's Parish School in Racine (with a meeting tentatively scheduled for Thursday, December 5, 1991). He also stated that he would authorize financial assistance for therapy costs, whatever may have occurred in 1963, through the office of Fr. Thomas Venne the current Vicar for Clergy and indicated that he would share a copy of the formal document sent to him by Fr. Stoeffel detailing the restrictions in Ministry currently in place. He was strongly urged to invoke some kind of removal from office, or a form of administrative leave by [REDACTED].

[REDACTED] He was requested to inquire about an additional possible victim by the name of [REDACTED], also a graduate of St. Joseph's School of Grafton in 1967. He made a tentative appointment for Friday, December 6, 1991 in order to receive a formal notarized statement of [REDACTED] allegation and after consultation with Matt Flynn who chose not to be present, made arrangements with Fr. Joseph Perry to receive the notarized legal deposition as evidence of [REDACTED] seriousness in making the allegation.

On Thursday, December 5, 1991 Bishop Sklba met with Mr. Cooper, Principal of St. Joseph School in Racine, at the school office to discuss Mr. Cooper's concern that Fr. Mogilka had not informed him when the first news of the allegation surfaced in 1990. Mr. Cooper indicated that he had received intimations of some discomfort among the girls from second and third hand sources, and had kept the matter in mind without finding any reason for professional concern at this time.

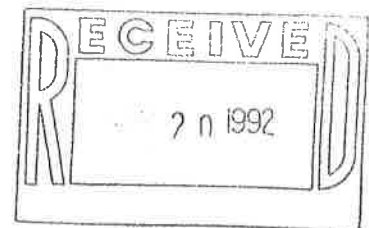



**SETTLEMENT AGREEMENT
AND MUTUAL RELEASE**

This Settlement Agreement and Mutual Release (hereafter "agreement") is made by and between ██████████ (hereafter sometimes referred to as "claimant"), and the Archdiocese of Milwaukee (hereafter "Archdiocese"), Raymond Adamski, and St. Joseph's Congregation of Grafton (hereafter sometimes collectively referred to as "defendants").

WHEREAS, the claimant has alleged certain claims for damages against the defendants, based on certain allegations that Raymond Adamski sexually abused ██████████ which allegations are more fully set out in the complaint in this case; and

WHEREAS, the defendants deny the liability alleged as set out in their answers; and

WHEREAS, the parties to this agreement wish to settle and compromise all claims of ██████████ against the Archdiocese of Milwaukee, Raymond Adamski, and St. Joseph's Congregation of Grafton, and against all of the Archdiocese's

and St. Joseph's employees, agents, officers, directors and assigns, including, without limitation, all members of the Roman Catholic clergy, all Roman Catholic schools, all parishes, including without limitation St. Joseph's Congregation of Grafton and any persons or entity affiliated with the Roman Catholic Church in the territory of the Archdiocese of Milwaukee, including, without limitation, all insurers of the Roman Catholic Archdiocese of Milwaukee and its affiliated entities, arising from the assaults and other conduct of Raymond Adamski alleged by [REDACTED] without the necessity of further expense and proceedings in this litigation, and wish to generally release one another from all liability for any claims that may exist to the date of the signing of the agreement, including, but not limited to, any sexual abuse or assault claim by [REDACTED] against the defendants, and against any other persons or entities listed above who may allegedly be responsible for the actions alleged;

NOW, THEREFORE, in consideration of the mutual promises herein provided and other valuable consideration, receipt of which is hereby acknowledged, the parties to this agreement hereby agree as follows:

1. The defendants agree to pay to [REDACTED] jointly the total sum of \$20,000, receipt of which is hereby acknowledged.

2. In return for the payment above, and for the mutual promises contained herein, and for other good and

valuable consideration, receipt of which is hereby acknowledged, [REDACTED] hereby releases and forever discharges St. Joseph's Congregation of Grafton, Raymond Adamski, the Archdiocese of Milwaukee, and all the Archdiocese's and St. Joseph's employees, agents, officers, directors and assigns, including, without limitation, all members of the Roman Catholic clergy, all Roman Catholic schools, all parishes, including without limitation St. Joseph's Congregation of Grafton and all of its employees, agents, officers, directors, and assigns, and any person or entity affiliated with the Roman Catholic Church in the territory of the Archdiocese of Milwaukee, from and covenants not to sue them for, all claims, causes of action, charges, and demands of any nature, whether in tort, contract, or otherwise including but not limited to conspiracy and punitive damages, that they may have had at any time up to and including the date of the signing of this agreement, including but not limited to any claims arising from any assault, injury, whether physical or mental, or any other activity of Raymond Adamski, including any claim for loss of companionship or other damages, and including all claims set out in the above captioned complaint.

3. Raymond Adamski, St. Joseph's Congregation, and the Archdiocese of Milwaukee hereby release and forever discharge [REDACTED] from all claims, demands, and causes of action of any nature that they may have had up to and including the date of the signing of this agreement.

4. All parties agree that the above captioned action may be dismissed with prejudice, on the merits, and without costs to any party. They further agree that their attorneys will execute a stipulation for dismissal in the form attached as Exhibit A. Each party will bear its own attorneys' fees in this matter.

5. The claimant and defendants mutually agree that neither they nor their attorneys nor representatives will reveal to anyone, other than to their attorneys, to their therapists or counselors in the course of psychological treatment, counseling, psychotherapy, or AODA, or as required by law in connection with claimant's [REDACTED] or if required by legal compulsion, unless mutually agreed to in writing, any of the terms of this agreement or any of the amounts, numbers or terms and conditions of any sums payable to the claimant hereunder. Claimant hereby understands and agrees that this confidentiality section of the agreement is of paramount importance and that observance of this confidentiality section is of the essence to the agreement achieved between the parties. All parties agree to abide by the terms of this confidentiality section as consideration for and as an integral part of the agreement.

6. Nothing in this agreement shall be construed as an admission of liability on the part of any party.

7. [REDACTED] declares that she has read the foregoing agreement; discussed it with her lawyer; and fully understands its terms. [REDACTED] further declares that

she has obtained professional counseling for the injuries and assaults alleged and understands their impact on her, and understands that her condition could worsen in the future; declares that she is entering into this agreement with the advice of the lawyer retained by her; and declares that she voluntarily accepts the terms and sum of money under this agreement for the purpose of making a full and final compromise, adjustment and settlement of all claims of any nature that she may have against the defendants.

As you know, I have been following and managing his course of peripheral neuropathy over the last year or two. He has more recently been in a private facility here in Milwaukee. He has not progressed to any significant degree. He finds that he is fairly stable and feels as though he could manage if he were back at the home for priests. I concur. I think there is no definite reason why he should stay where he is and I see no reason why he couldn't move back to the other retirement home. Therefore, my recommendation is to allow him to do that. I will continue giving him the Vitamin B12, which he will have to get once a month. Arrangements can be made for that to be done locally. He also needs to follow-up with either his primary physician or myself. Therefore, I see no problem for him to come back.

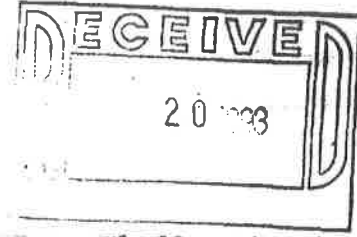

On Tuesday, January 12 we received a call from Fr. Adamsky's attorney stating that Father had been contacted by a Sentinel reporter saying that a civil suit had been filed against him and wanting a comment. (The suit arises from a charge that in 1963 Father improperly touched the woman when she was 10 years old. The incident allegedly occurred at St. Joseph Parish School in Grafton. Father denies the allegation.) Father referred the reporter to his lawyer who said he had not seen any papers filed. He wanted to know if we had been served and we said no. We decided to make our various contacts by phone rather than try to convene a meeting. Since Fr. Tom Venne was on vacation, Fr. Tom Trepanier became our key contact. It was decided that he would contact the administrator at the nursing home (he had previously advised her that an allegation was possible) to inform her of the matter. In fact when he called Fr. Adamsky had already notified her and the matter was well in hand on their end. The decision was made to leave Father in place there. We contacted Fr. Jim Kimla, pastor of St. Joseph Parish in

Grafton which was also named in the suit. He was given the same information and advice as noted in the case above. Neither Mary Kay nor Therese was in that day so we contacted Maureen Gallagher and simply informed her (without giving any priest's name) that a parish intervention team might need to be assembled with a school component to it. She agreed to be "on-call" as needed. Tom Schneider was notified (no names given) in case we would need some CSS assistance.

Nothing ever appeared in the papers on this case. The Archdiocese and the parish have been served and the papers forwarded to Matt Flynn's office. Again, no decision was made about parish interventions.

**SETTLEMENT AGREEMENT
AND MUTUAL RELEASE**

This Settlement Agreement and Mutual Release
(hereafter "agreement") is made by and between [REDACTED]

[REDACTED]
(hereafter sometimes referred to as "claimant"), and the Roman Catholic Archdiocese of Milwaukee (hereafter "Archdiocese"), Raymond Adamsky, and St. Philip Neri Catholic Church (hereafter "St. Philip Neri"), hereafter sometimes collectively referred to as "respondents".

WHEREAS, the claimant has alleged certain claims for damages against the respondents, based on certain allegations that Raymond Adamsky sexually abused [REDACTED] in or around 1971, and continuing for a period of time thereafter; and

WHEREAS, [REDACTED] further alleges that the Archdiocese and St. Philip Neri may be liable for the actions of Raymond Adamsky that give rise to the alleged claims; and

WHEREAS, the respondents deny the liability alleged and there is a dispute between the parties; and

WHEREAS, the parties to this agreement wish to settle and compromise all claims of [REDACTED] against the Archdiocese of Milwaukee, Raymond Adamsky, and St. Philip Neri Catholic Church, and against all of the Archdiocese's and St. Philip Neri's employees, agents, officers, directors and assigns, including, without limitation, all members of the Roman Catholic clergy, all Roman Catholic schools, all religious orders, all parishes, including without limitation

St. Philip Neri and any persons or entity affiliated with the Roman Catholic Church in the territory of the Archdiocese of Milwaukee, including, without limitation, all insurers of the Roman Catholic Archdiocese of Milwaukee and its affiliated entities, arising from the assaults and other conduct of Raymond Adamsky alleged by claimant, without the necessity and expense of formal litigation, and wish to generally release one another from all liability for any claims that may exist to the date of the signing of the agreement, including, but not limited to, any sexual abuse, assault, negligent supervision, or other claim by [REDACTED] against the Archdiocese and St. Philip Neri, and against any other persons or entities listed above who may allegedly be responsible for the actions alleged;

NOW, THEREFORE, in consideration of the mutual promises herein provided and other valuable consideration, receipt of which is hereby acknowledged, the parties to this agreement hereby agree as follows:

1. The respondents agree to pay to [REDACTED] jointly the total sum of \$40,000, receipt of which is hereby acknowledged. All parties will bear their own costs and attorneys' fees associated with this settlement.

2. The respondents jointly agree to pay for two years of psychotherapy expenses for [REDACTED] with a cap on those expenses per year of \$5,000. Therapy bills are to be submitted directly to the Archdiocese from a licensed therapist approved by the Archdiocese's Professional Review

Panel, and will be promptly paid upon receipt of those bills. Consent to [REDACTED] selection of a therapist will not be unreasonably refused, and the Professional Review Panel will inform [REDACTED] within thirty days of her designation of a therapist whether or not that therapist has been approved, with reasons given in the event of refusal. At [REDACTED] election, the therapy under this paragraph may be individual psychotherapy or family psychotherapy. The parties further agree that the Archdiocese shall make payment to the therapist for reasonable bills, charged at the customary normal rate charged by that therapist to his or her patients generally, for therapy services actually provided to [REDACTED] for up to a capped amount of \$5,000 a year for two years commencing on April 1, 1995, and ending on April 1, 1997. The total joint obligation of the respondents under this paragraph shall not exceed \$5,000 for any individual year, nor shall it exceed a total of \$10,000 for the two year period.

3. In return for the payments above, and for the mutual promises contained herein, and for other good and valuable consideration, receipt of which is hereby acknowledged. [REDACTED] hereby releases and forever discharges St. Philip Neri, Raymond Adamsky, the Roman Catholic Archdiocese of Milwaukee, and all the Archdiocese's and St. Philip Neri's employees, agents, officers, directors and assigns, including, without limitation, all members of the Roman Catholic clergy, all Roman Catholic schools, all

religious orders, all parishes, including without limitation St. Philip Neri Catholic Church and all of its employees, agents, officers, directors, and assigns, and any person or entity affiliated with the Roman Catholic Church in the territory of the Archdiocese of Milwaukee, from and covenants not to sue them for, all claims, causes of action, charges, and demands of any nature, whether in tort, contract, or otherwise including but not limited to negligent supervision, respondeat superior, conspiracy, and punitive damages, that she may have had at any time up to and including the date of the signing of this agreement, including but not limited to any claims arising from any assault, injury, whether physical or mental, or any other activity of Raymond Adamsky, including any claim for loss of companionship or other damages.

4. Raymond Adamsky, St. Philip Neri Catholic Church, and the Archdiocese of Milwaukee hereby release and forever discharge the claimant from all claims, demands, and causes of action of any nature that they may have had up to and including the date of the signing of this agreement.

5. As a condition precedent to the payment of the sum set out in paragraphs 1 and 2, [REDACTED] hereby agrees not to disclose to any third-party, including, without limitation, any newspaper, any electronic media, any reporters, any other attorneys, and any other individual, or to release for publicity any of the allegations which have been made against Raymond Adamsky, St. Philip Neri, and the

Dear Ms. Piasecki,

While I was pleased to hear that the Archbishop was open to a financial settlement in regards to the sexual abuse that took place during my adolescence by Fr. Adamski, I was surprised by the amount suggested. The first \$20,000 only reimburses me for the actual expenses I've incurred in direct therapy and the therapy related expenses over the years. The remaining \$10,000 barely covers legal, mediation and annulment expenses we now face as divorce proceedings begin.

The amount offered does cover monetary damages the abuse has caused in my life. It does not even begin, however, to address the extensive emotional and psychological costs which I have previously outlined. I realize that no amount of money can take away the overall affects the abuse has had on me directly and on the rest of my family indirectly. This settlement, though, should both reimburse monetary losses sustained and concretely reflect, thru financial means, the other losses also caused by the abuse. Only when I feel the Church has acknowledged the abuses overall severity and justly compensated me for all damages caused by a priest I had worked under and trusted can I feel a fair settlement has been reached. This will then enable me to continue on in the overall healing process.

My therapist, [REDACTED] and I have looked at the current goals of therapy which we identify as the continuation of dealing with the sexual abuse, its affects on my life, support during the process of divorce, exploring the possibility of future meaningful adult relationships and my moving on in life as a single parent. We concluded that a timeframe of 18 months (weekly for nine months and then tapering off gradually for the remaining nine months) is a realistic timetable.

I am hearing that it may be unrealistic to expect the Archbishop to come up to the original \$60,000 sought and I am thus willing to come down to \$50,000 plus the continued therapy coverage as outlined. The balance of \$20,000, after subtracting actual monetary expenses, is not an excessive amount of money considering the comprehensive detrimental impact this abuse has had upon my life.

I would appreciate a call or fax acknowledging the receipt of this letter and an anticipated timeframe as to when I can expect to hear back from you. Thank you very much for your anticipated continued cooperation.

Your Eminence:

In accord with the *Charter for the Protection of Children and Youth* and *The Essential Norms* which are in effect in the United States, I am referring several cases for your consideration. I take very seriously the problem of sexual abuse of minors by clergy and the ensuing public outcry over past inaction by church officials. The demand for justice is one that receives a favorable hearing from me.

However, I also believe firmly that some situations call for justice tempered by mercy. I have reviewed carefully all of cases of alleged sexual abuse of minors by clergy. We are in the methodical process of preparing all such cases for referral to the Congregation. In the course of that review, I have come to the conclusion that some clerics, even though we are convinced about the substance of the allegations and even though, in some cases, the cleric has confessed, should not be imposed with canonical penalties.

I am sending in this mailing the cases of those priests whose life situations are such that a canonical penal trial or an administrative dismissal would be unreasonable. They are either of such advanced age or fragile health that such actions could be tantamount to a death sentence. Therefore, in each case I am asking that the priest be permitted to live out whatever may remain of his life in prayer and penance. The elements of such a life will be designed along the protocols presently being prepared by the Conference of Bishops. In all cases, there would be no public ministry permitted and the priest would not present himself publicly as a priest by title or attire.

Thank you for your consideration of these requests. Should Your Eminence determine that an alternate action be taken, I stand ready to accede to your wishes.

CIVIL PROCEEDINGS AGAINST THE CLERIC

The Milwaukee District Attorney reviewed the files and determined that all cases were beyond the statute of limitations.

Civil settlements were reached with two of the victims in the amounts of \$20,000 and \$50,000.

SUSTENANCE PROVIDED TO THE CLERIC

Father is fully vested in the priests' pension plan and receives the same monthly payment as any other retired priest. He resides in diocesan sponsored housing with reduced room and board.

RESPONSE / RECOURSE MADE BY THE CLERIC

Father admitted the events from 1983 but said they were misconstrued. All other allegations he claims lack of memory even though none of the accusers know one another and all sequence of dates match up not only with the place of assignment but also with transfers that are not explained in the files.

BISHOP'S VOTUM

The pattern of the allegations has an internal consistency. All of the dates and places are verified in the records. The accusers have no knowledge of or contact with one another. Father admits to one incident but dismisses its seriousness. He claims lack of memory for all others. These cases have been given no public notoriety and there has been no scandal. Despite the evidence of probable guilt, I am asking that Father Adamsky not be subjected to a penal trial. His health has deteriorated significantly in recent years. He has agreed not to appear in public wearing priestly attire and to live with the restrictions contained in the precept, namely that he have no contact with minors and no public ministry. He is permitted to say private Mass only and his confessional faculties have been revoked.

I ask that Father Adamsky, for reasons of advanced age and poor health, be permitted to live a life of prayer and penance the details of which will be worked on with him.



AGREEMENT AND MUTUAL RELEASE

This Agreement and Mutual Release (hereafter "Agreement") is made by and between [REDACTED] hereafter [REDACTED], and the Roman Catholic Archdiocese of Milwaukee, and all of its affiliated entities, schools, and parishes, including, without limitation, St. John Congregation and School (hereafter "Archdiocese").

[REDACTED] has brought to the attention of the Archdiocese that she was sexually abused by Raymond Adamsky (hereafter "Adamsky"), a priest of the Archdiocese, when [REDACTED] was a minor.

[REDACTED] and the Archdiocese entered into mediation to achieve reconciliation and restoration, to help repair the harm to [REDACTED] and to otherwise resolve and settle all disputes between them.

Accordingly, the parties to this Agreement wish to resolve and satisfy all claims of any nature that [REDACTED] has against the Archdiocese, and all of the Archdiocese's employees, agents, insurers, officers, directors, affiliates, and assigns, including, without limitation, all members of the Roman Catholic clergy and all parishes, schools, and religious orders, and any person or entity affiliated with the Roman Catholic Church in the territory of the Archdiocese, arising from the sexual abuse of [REDACTED] by Adamsky without the necessity of further proceedings or expense of any nature, and all parties wish to generally release one another from all liability for any claims that may exist to the date of the signing of this Agreement, including, but not limited to, any claims for sexual abuse of [REDACTED] by Adamsky.

So, in consideration of the mutual promises made here, and other valuable consideration, receipt of which is hereby acknowledged, the parties to this Agreement agree as follows:

1. The Archdiocese agrees to provide [REDACTED] with \$50,000. These funds shall be used at [REDACTED] discretion.

2. The Archdiocese of Milwaukee agrees to provide reimbursement for one half of the monthly insurance premium for [REDACTED] and her husband's health coverage commencing September 1, 2004 and continuing until the month ending when [REDACTED] reaches age 65. Reimbursement shall be limited to premiums that have actually been paid by [REDACTED] and must be accompanied by written verification showing a) the premium invoice, and b) the payment of it. Reimbursement shall be payable by the Archdiocese on a quarterly basis on the written verifications [REDACTED] has provided. This agreement is based on the insurance plan currently in place, *including normal and ordinary premium increases.* [REDACTED] *TAC* The Archdiocese is not liable for any additional expenses associated with the coverage such as, by way of example, deductible amounts, co-pays, or other charges. The Archdiocese is not responsible for any changes in insurance coverage made by the insurance company, the organization which makes the coverage available, or any other agency or entity.

3. The Archdiocese agrees to present to Archbishop Dolan, [REDACTED] written statement and to request a written response from him. The Archdiocese will arrange to have [REDACTED] written statement entitled "Impact Statement" read to Adamsky.

4. [REDACTED] and the Archdiocese will each bear their own costs and any attorney's fees associated with the settlement, and there will be no payment to [REDACTED] other than that specifically enumerated in these paragraphs.

5. In return for the payments set out above, and for the mutual promises contained herein, [REDACTED] releases and forever discharges the Roman Catholic Archdiocese of Milwaukee, and all of the Archdiocese's employees, agents, insurers, officers, directors, affiliates, and assigns, including, without limitation, all members of the Roman Catholic clergy, and all parishes, schools, and religious orders, including, without limitation, St. John Congregation and School and any person or entity affiliated with the Roman Catholic Church in the territory of the Archdiocese of Milwaukee from, and covenants not to sue them for, all claims, causes of action, charges, and demands, whether in tort, contract, or otherwise, of any nature that he may have had at any time up to and including the date of signing of this Agreement, including, without limitation, any claim of any nature arising from the assault, injury, whether physical or mental, or any other activity by Adamsky.

6. The Archdiocese hereby releases and forever discharges [REDACTED] from all claims, demands, and causes of action of any nature that were in existence up to and including the date of the signing of this Agreement.


7. This Agreement supersedes all prior understandings and agreements between the parties, and constitutes the full agreement of the parties. No change to this Agreement shall be enforced against any party unless it is in writing signed by both parties.

8. The undersigned represent and warrant that each has read the foregoing Agreement; had an opportunity to discuss it with a lawyer; and fully understands its terms; voluntarily, freely, and without coercion signs the Agreement; and that Dr. Barbara Anne

Cusack is an authorized representative of the Archdiocese and is duly authorized to execute this Agreement and Mutual Release.

Dear Reverend Weakland,


I am a 42 year old woman who has been sexually abused by a priest almost 30 years ago when I was the young age of 13. Nobody ever knew of this abuse when I was a child because this priest told me never to tell my mother. Believing that a priest would never mislead me, I told no one and swallowed the guilt and believed that I must have done something wrong to have had this happen to me. I carried this "secret" and the guilt for 26 years.

My concern today is to relate to you the impact that sexual abuse has upon a victim and to express the great need for the Catholic Church to acknowledge that abuse has taken place, listen to it's victims, and to take steps to insure that those who sexually abuse will not be protected.

In October, 1992 the story of sexual abuse by a priest in Sheboygan was told through television news and the local paper. In the October 29th issue of the Milwaukee Journal a continuing story of this issue was published. As a part of this article, there was a notice given with the words, "The Milwaukee Catholic Archdiocese asks that anyone who had been abused by a priest call Father Thomas Vinne at (414)-769-3484." When I saw this, I knew it was time for me to "break the silence" and to let "the church" know the devastating event that took place when I was a young, innocent, trusting child. I called the number and was told I would be connected with a woman by the name of Mary Kay. I told her what had happened to me. She was kind, empathetic and apologized on behalf of the church for the sexual abuse. She expressed concern for me, that I had available a support system for my well-being. She asked me the name of the priest and I did disclose this to her but asked that my name not be identified to this priest. She also asked if I would be willing to talk to either you or Father Vinne regarding my sexual abuse. I indicated to her that I would agree to this. To date, I have had no call, conversation or acknowledgement that what I told Mary Kay was validated.

I have struggled a long time before writing this letter as I also struggled to make that phone call. Reverend Weakland, I realize that many issues regarding sexual abuse have surfaced, that you do take seriously these allegations and that the church is going through a very difficult time. But I feel as though I have once again been let down by the church. I was told that somebody would talk to me about my sexual abuse incidents. This has not happened. An apology from Mary Kay on behalf of the church is not enough. I have spent approximately \$13,000 of my own money in therapy these last four years. In addition, approximately \$8,000 has been spent by my insurance company for this same purpose.



I am once again going to name the priest who abused me but ask that I not be identified to this priest, if indeed he is still living. Father Raymond Adamsky sexually abused me when he was assigned to St. John's parish in   My request to you is to let me know if indeed Father Adamsky is alive and if any other sexual abuse allegations against him have been received.

It is time for victims to "break the silence". But the church needs to validate these individuals, not just with an apology but with continuing dialogue, especially with victims, so that other innocent children do not become the next victims. Select Adamsky Sexual Abuse Intake Reports

- 8/6/89 Letter from unknown sender (redacted) to Sklba saying that she was abused by an unnamed priest when she was ten years old. The abuse occurred daily for two weeks. The principal of her school warned her to stay away from the unnamed priest.
- 9/28/94 Sexual abuse intake report from a woman who was abused by Adamsky when she was 13 in approximately 1971 at St. Philip Neri Parish. Adamsky abused her two to four times at the parish and during private social outings.
